



**ORDINANCE AUTHORIZING THE UTILITIES DIRECTOR  
TO EXECUTE A STANDARD SOLAR ENERGY SCHEDULE  
WITH AMP, INC., FOR UP TO 2.0 MEGAWATTS OF  
POWER FROM SOLAR ELECTRIC FACILITIES,  
AND DECLARING AN EMERGENCY**

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BOWLING  
GREEN, OHIO, COUNTY OF WOOD, STATE OF OHIO:

SECTION 1: That the Utilities Director is hereby authorized to  
execute a standard solar energy schedule with AMP, Inc., for up to 2.0  
megawatts of power from solar electric facilities.

SECTION 2: This ordinance shall take effect as an emergency  
measure in order to meet the contract deadline date, thereby protecting the
