ORDINANCE AUTHORIZING THE UTILITIES DIRECTOR TO ADVERTISE FOR BIDS AND ENTER INTO A CONTRACT OR CONTRACTS FOR ELECTRIC LINE RELOCATION CONSTRUCTION FOR THE NORTH MAIN STREET WIDENING PROJECT, AND DECLARING AN EMERGENCY

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BOWLING GREEN, OHIO, COUNTY OF WOOD, STATE OF OHIO:

SECTION 1: That the Utilities Director is hereby authorized to advertise for bids and enter into a contract or contracts for electric line relocation construction for the North Main Street widening project.

SECTION 2: This ordinance shall take effect as an emergency measure. The reason for the emergency is to allow for the completion of this portion of the project in a timely manner prior to the commencing of road widening project scheduled by the Ohio Department of Transportation for early 2011, thereby protecting the public peace, safety, and welfare of our citizens.
